Written procedure No.02, initiated 16.01.2023

1. Description:

The Written procedure for approval of changes in the partnership under the project with ref. No CB007.2.12.158, "The Taste of Tradition - the Intangible Cultural Heritage of Vidin and Bor for sustainable tourism" and amendment of the Eligibility of Technical Assistance Expenditures under the Interreg – IPA CBC Bulgaria – Serbia Programme 2014-2020, was initiated by the Head of the Managing Authority and co-chair of the MC on 16.01.2023.

The modification concerning the partnership under the project with ref. No CB007.2.12.158 consists of replacing of Project partner 3 - Society for Preservation of Vlachs' Culture "Timok's Valley", Oshrel village, Municipality of Bor, Republic of Serbia with "Center for Intangible Cultural Heritage "Roots", Zajecar, Republic of Serbia.

The amendment of the Eligibility of Technical Assistance Expenditures under the Interreg – IPA CBC Bulgaria – Serbia Programme 2014-2020 concerns an update of the maximum total amount (threshold) of remuneration of the Head of the FLC unit and controllers in Bulgaria.

The official letter No. 99-00-2-21/16.01.2023 with the proposed amendments, was sent to the MC members via e-mail, for review and approval.

The MC members were given 5 working days to send their approval or comments on the proposed documents. Only opinions of approval were received.

2. Decisions:

Decision 1:

The Monitoring Committee approves the change in the partnership of project with reference number CB007.2.12.158, "The Taste of Tradition - the Intangible Cultural Heritage of Vidin and Bor for sustainable tourism".

Decision 2:

The Monitoring Committee approves the amendment of the Eligibility of Technical Assistance Expenditures of the Interreg – IPA CBC Bulgaria – Serbia Programme 2014 – 2020.


The hereby decision enter into force on 24th January 2023 – the date following the deadline for submission of comments from the MC.
