Written procedure No. 10, initiated on 24 March 2017

1. Description:

The Written procedure for approval of modifications in three projects, funded under the First Call for proposals of the Interreg – IPA Cross-border Cooperation Bulgaria - Serbia Programme 2014-2020, was initiated by the Co-chairperson of the Joint Monitoring Committee (JMC) from Bulgarian side on 24 March 2017. The modifications include change of partnership under project No CB007.1.12.174 “Bulgarian-Serbian GourmeTrain”, modification of project content under project No CB007.1.11.143 “Recreative and sports sites as tourist potential of the region”, and inclusion of additional own co-financing under project No CB007.1.11.124 “Conservation, revitalization and exhibition of Early Christian basilica and medieval fortress in cross border region”.

The official letter No. 99-00-2-274/24.03.2017 was sent to the JMC members via the JMC section of the internet site of the Programme and the Management Information System, for review and approval.

The JMC members were given 10 working days to send their approval or comments on the proposals. The only remarks received, within the set deadline, were opinions of approval.

2. Decisions:

JMC approves the following modifications of projects, funded under the First Call for proposals of the Interreg – IPA Cross-border Cooperation Bulgaria - Serbia Programme 2014-2020:

- Change of partnership under project No CB007.1.12.174 “Bulgarian-Serbian GourmeTrain”, concerning replacement of the Lead partner – Regional Chamber of Commerce and Industry Leskovac with Chamber of Commerce and Industry Serbia;
- Modification of project content under project No CB007.1.11.143 “Recreative and sports sites as tourist potential of the region”, concerning the investment activities of the Lead partner, namely change of the spot of one of the foreseen fitness sites;
- Inclusion of additional own co-financing amounting at 4 950 EUR under project No CB007.1.11.124 “Conservation, revitalization and exhibition of Early Christian basilica and medieval fortress in cross border region”.


The hereby Decision enters into force on the 07 April 2017 - the date following the deadline for submission of objections / additional proposals from the JMC members.


