**Written procedure No. 6, initiated on 07 November 2016**

**1. Description:**

The Written procedure for approval of the proposals related to the signature of subsidy contracts under the Interreg – IPA CBC Bulgaria - Serbia Programme 2014-2020:

1. Proposal not to conclude subsidy contract with project CB007.1.21.282 “Improvement of youth-related infrastructure in the cross-border region Rila-Sokobanja (Cross-Border Youth Zone)”, due to incomplete technical documentation and its inconsistency with the description of the investment activities;
2. Proposal for signature of additional subsidy contract with project CB007.1.21.378 “Virtual Enterprises”, in the frames of the available funding under Priority Axis 2;
3. Updated information on projects CB007.1.11.273 and CB007.1.11.151, regarding technical mistakes in the final contract amounts,

was initiated by the Co-chairperson of the Joint Monitoring Committee (JMC) from Bulgarian side on 07 November 2016.

The official letter No. 99-00-2-1024/07.11.2016 was sent to the JMC members via the JMC section of the internet site of the Programme, for review and approval.

The JMC members were given 5 working days to send their approval or comments on the proposals. The only remarks received, within the set deadline, were opinions of approval.

**2. Decisions:**

JMC approves the proposals related to the signature of subsidy contracts under the Interreg – IPA CBC Bulgaria - Serbia Programme 2014-2020:

1. Proposal not to conclude subsidy contract with project CB007.1.21.282 “Improvement of youth-related infrastructure in the cross-border region Rila-Sokobanja (Cross-Border Youth Zone)”;
2. Proposal for signature of additional subsidy contract with project CB007.1.21.378 “Virtual Enterprises”;
3. Updated final contract amounts of projects CB007.1.11.273 (556 028,60 Euro) and CB007.1.11.151 (577 306,33 Euro).


The hereby Decision enters into force on the 12 November 2016 - the date following the deadline for submission of objections / additional proposals from the JMC members.






