Written procedure No. 49, initiated on 20 November 2020

1. Description:

The Written procedure for approval of the Pre-contracting report for the performed pre-contracting procedures on project with reference number CB007.2.11.064 from the reserve list of Priority Axis (PA) 1 "Sustainable tourism" under the Second Call for Proposals No 2014TC16I5CB007-2018-2 of the INTERREG - IPA CBC Bulgaria - Serbia Programme 2014-2020, was initiated by the Co-chairperson of the Joint Monitoring Committee (JMC) from Bulgarian side.

Based on two JMC Decisions (from 2 October 2019 and 25 February 2020) and the amendment of the Programme (approved with EC Decision C(2020)5506/07.08.2020), related to budget reallocation between priority axes and financing of projects from the reserves lists under the Second Call for Proposals, the project proposal CB007.2.11.064, with Lead Partner (LP) - Municipality of Belogradchik, is proposed for funding, upon fulfillment of two conditions:

1. In case of availability of funds under the Programme;
2. If the LP presents additional documents, within 2 weeks period following written notification by the Managing Authority:
 - Investment Project approved by the Ministry of Culture and Chief Architect of the municipality (under Art. 142 para 1, Art. 143, para 1 point 5 and Art. 144, para 1 point 4 of the Spatial Development Act);
 - Building Permit issued by articles 148, para 4 of the Spatial Development Act or Statement that building permit is not required (issued by the relevant body according national legislation).

In case the above conditions are not met, the project proposal will be declined from signature of subsidy contract

The official letter No. 99-00-2-323/19.11.2020 with the request for approval of the Pre-contracting report under project proposal CB007.2.11.064 was sent to the JMC members via the Management Information System of the Programme, for review and approval.

The JMC members were given 3 working days to send their approval or comments on the request for approval. Only opinions of approval were received.

2. Decisions:

JMC approves the Pre-contracting report for the performed pre-contracting procedures on project proposal CB007.2.11.064 from the reserve list of PA 1 "Sustainable tourism" under the Second Call for Proposals No 2014TC16I5CB007-2018-2 with LP - Municipality of Belogradchik, as well as the related proposal for conditional contracting.

The hereby Decision enters into force on 25 November 2020 - the date following the deadline for submission of objections / additional proposals from the JMC members.




